The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Prices

Basic Services and Fees of Funeral Director and Return Home Staff - This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for Terramation (natural organic reduction) and receiving remains.

Terramation (Natural Organic Reduction) \$4,950

Includes: Basic Service Fee; Transfer of Remains to Funeral Home; disposition of remains into compost through the process of Terramation (Natural Organic Reduction). Delivery of excess soil to land in need of restoration.

Basic Service Fee \$300

Includes: Services of Return Home Staff and Licensed Funeral Director (including conducting the arrangements conference, securing the necessary permits, coordinating with third parties as necessary – including, but not limited to Veteran’s Administration (VA) and/or other insurance, preparing notices, coordinating arrangements and related administrative work); Sheltering and refrigeration of the deceased remains for a period of up to one week; Online memorial.

Transfer of Remains to Funeral Home. \$200

Includes: Removal of deceased from home, local hospital or care facility within 75 mile radius of Return Home’s Auburn Location (additional \$3 per loaded mile beyond this range).

Receiving Remains \$1,000

Includes: Basic Service Fee, assistance with facilitating transportation arrangements and receipt of remains from an out-of-state funeral home.

Laying In Ceremony \$500

Includes: Preparation of Remains (washing and disinfecting remains, cosmetics, and dressing in compostable garment); video tribute option; live webcast of ceremonies; and one-hour use of Return Home facility for private visitation.

Essential Service at Point of Contact \$500

Includes: transportation from place of death and refrigeration for the 1st week of holding.

Special Care of Body. \$500

Includes: extensive restoration in addition to basic preparation due to autopsy, bone donation, or major trauma

Delivery. \$300

Includes: packaging, labeling, and scheduled delivery of compost to home or property (WA residents only).

Remains Forwarding Policy

Return Home does not ship human remains by air at this time. We will, however, recommend other funeral homes who can provide this service.

At this time, Return Home does not ship soil outside of the United States.

The following disclosures are required by the Federal Trade Commission (FTC) Funeral Rule;

FTC Funeral Rule Required Embalming Disclosure

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Clarification from Return Home

Return Home's Terramation process cannot be performed on embalmed bodies at this time. If you are sure that the body will be embalmed, you will need to utilize an alternative method of final disposition.
